Randall Genealogy.



The family name of RANDALL is distinctly traceable back to the period of the Norman conquest of England, A. D. 1086. It first appears in the celebrated "Domes Day-Book" of William the Conqueror, in the assignment of lands to individuals bearing this name, as *tenants in capite*, immediately from the crown, and restricted to those who accompanied the Conqueror from his native Kingdom of Normandy, of which they may have been native citizens, or the descendants of those who came over from Denmark or Norway, with Rollo the Dane, at the beginning of the tenth century, A. D. 901.

The name of John Randall is of frequent occurrence in the year books, or records of legal proceedings and judicial decisions, from the beginning of the reign of Edward II. to the end of that of Henry VIII.—a period of about two hundred years from 1327 to 1547. In the topographical and genealogical survey of England, under date of April 30, 1570, there is a record of the marriage of John Randall to a Sussex heiress, and in 1600, of Levi Edward Randall to Ann Morgan, of Sussex.

From about 1620 to the end of the century, the names of several of the family appear in the ancient records and archives of the Northern and Eastern Colonies; but from their early diffusion it is really impossible to trace any one family of the present period from its English or American ancestors.

The present table is confined chiefly to the earliest ascertainable settlement of those branches of the Randall family in the Colonies of Rhode Island, Connecticut, New York and Massachusetts, designated herein as the New England settlers, and traceable from thence to New York, Ohio, Indiana and other Western States.

There is much uncertainty regarding the early history of our ancestor, JOHN RANDALL, from whom we commence this genealogical record. It is known that several persons by the name of Randall were among the early settlers of New England.

William Randall, of Scituate, Mass., was a prisoner "from ye port of London, in the ship Expectacon, ye 24th of April A. D. 1635, to the Island of Providence."

Widow Elizabeth Randall and her sons, Stephen and John, were at Wattertown, Mass., in 1653.

Robert Randall was made freeman at Weymouth, Mass., in 1647; and Goodman Philip Randall, of Dorchester, Mass., was a freeman in 1634.

Abraham Randall sailed in company with Rev. John Wareham, from Plymouth, Eng., for Boston, Mass., 30th March 1630, in the ship Mary and John.

Nathaniel, son and heir of John Randall, of Parish St. James, Clerkinwell Co., Eng., received a land grant in Groton, Ct., in 1650.

William Randall, of Newbury, Mass., born 1615.

But after the most thorough search and investigation, it is conclusive that our progenitor, JOHN RANDALL, of Westerly, R. I., was not a descendant of either of the above named families.

From a letter written January 1st, 1678; found by Mr. William R. Staples, among the old town records of Providence, R. I., it appears that in 1665 several members of the Newport, R. I., congregation removed to Westerly, R. I., and, the record says, "sat down there under the preaching of Rev. John Crandal."

This letter, signed by JOHN and Elizabeth RANDALL and four others, is addressed to the Newport Church, "from which they had come out." Thus we may fairly presume that Newport, R. I., was his first place of settlement in this country. But the destruction of both town and church records of Newport, early in the Revolution, deprives us of anything more satisfactory or definite than is here given.

In about 1671 the Westerly settlers embraced generally the seventh day Sabbath, and in 1708 they formed a separate church.

The following is a literal copy of the letter written to the Newport Church, referred to above.

Westerly, this 1st of the first month, 1678

We your brethren and sisters, assembled together at the hous of Tobias Sanders, wisheth you all grace mercy and peac in our Lord Jesus Crist and that boath you and we may stand feirm suer and stable in the faith and order of the Gospell til he coms who will com and will not long tarry to whom be prais onner and glory throughout all his churches world without end amen.

Dear and well beloved in our Lord Jesus Crist, this may signifi unto you that your carfull salutacion wee recevd dated the 13. of the 12. month last past by Peter Crandall, for which as duti and good afections binds us wee return you thanks hoping that thees will find you in good health as wee ar through mercy at this present in health and in peac. And can assemble ourselves to geather non making us afraid. We do desier that this great priviledg may be prized according to the valy of it and that wee might not wax wanton and carless under such great injoyments but that boath you and us may carfully stand upon our watch and earnestly crave the assistanc of his holy sperit so that nither this or any other of his Benefits may slip out of our minds to that end wee earnestly desier your praier to almyty God the father of our Lord Jesus Crist that he will (be) pleased to give us such many fistacions of his holy spirit that we may stand in the faith and order of the Gospell fast that wee have visibly profest before Heaven and many other witness hear upon Earth.

And not to loke at it as a Light or a slaight thing to break covinant with God and on with another. Let us tharfor be much in praier to God that he will give us wisdom and understanding that wee may not only discover but may by the assistanc of his blésed spirit be able to resist the wilds of the Divill for certainly if ever he was transformed into an Angell of Light it is now. And if it wear possible he would deceive the very Elect. Beloved Bretheren our praier unto God is for you that ye may like good soldiers stand with your loins girt redi to resist the adversary and not to give way though he com with never so faier pretences. Nay though he brings Law in his mouth ye ar not to be Lieve him: whear for dearly beloved seeing it is so that wee ar so besett with Enemies *without* and within let us be earnest with the Lord one for the other for the assistanc of his holy spirit that so wee may be able to withstand temtacions. we also return thanks to the.congragacion for the meshengars thay sent the last year wee hope their Labour of Love was not

Lost nor it in vain. which wee hope will be good in Coragement for you to remember another time your duti in that Respect.

Regarding the early settlement of John Randall at Westerly, R. I., Hon. J. Hammond Trumbull writes as follows :

HARTFORD, Ct., Feb. 16th, 1875.

P. K. RANDALL, Esq. :

DEAR SIR—In reply to yours of 5th inst., I can do no more than give you the following extracts from my note book :

JOHN RANDALL was at Westerly, R. I., in territory claimed by Connecticut as in Stonington, in 1667, and a farmer in 1669. In 1670 he bought a lot of land on the Pawcatuck river, of Thomas Bell, and was admitted an inhabitant of Stonington, 30th November, 1670. In 1678 JOHN and Elizabeth RANDALL subscribe the letter of the Westerly Baptists. In 1682 JOHN RANDALL was a deputy from Westerly to the R. I. Assembly, and in 1679 took the oath of fidelity to Rhode Island.—*Potter's Narraganset, Vol. II., page 103.*

August 16, 1720, John and Matthew Randall—one aged about fifty-four and the other forty-nine—testify that they had lived the greater part of their lives on or near Pawcatuck river. Their deposition is in Connecticut archives. These probably were sons of John and Elizabeth Randall above mentioned.

A Stephen Randall had rights Chs. recorded at Stonington, between 1698 and 1719, &c.

[*Extracts from Westerly (R. I.) Town Records.*]

At a meeting of the free inhabitants of Westerly, May 18th, 1669, in which the town was started, &c.

At a court held in His Majesty's name, at Westerly, in the king's province, September 17th, 1669, JOHN RANDALL took the oath of allegiance.

Town meeting, September 22d, 1679, JOHN RANDALL was appointed on a Committee. April 29th, 1680, JOHN RANDALL was chosen Juryman.

September 21st, 1682, JOHN RANDALL and John Babcock chosen Deputies for the town, to attend the General Assembly to be held at Warwick, for the Colony, on the third Wednesday of October next.

Extracts from Town Records of Stonington, Ct., show that in 1670 Thomas Bell, of that town, sold to John Randall, then a citizen of Westerly, R. I., three hundred acres of land lying east of the Ashaway river—a part of which has to the present time (1878) been in the possession of the Randall family, and now occupied by Mr. Darius Hewitt Randall. The authorities of Stonington took exceptions to this sale to a citizen of Rhode Island, and on the 9th of August, 1670, at a legal meeting warned according to an order, "the town did generally manifest themselves, that they were not satisfied with Thomas Bell's propounding his land to the town, because it was propounded at a meeting of the freemen, and not at a legal town meeting." And therefore "the town do

generally protest against Thomas Bell's act in selling his land to JOHN RANDALL, unless the said Randall come to Stonington and give satisfaction according to order and the law of the Colony."

November 30, 1670, JOHN RANDALL was admitted an inhabitant of Stonington. In 1685 Elizabeth, widow of JOHN RANDALL, petitioned for privilege to improve her deceased husband's land.—*N. E. Reg.*, 1861.

JOHN and Elizabeth RANDALL, according to the best attainable evidence, had four sons, viz: John, Jr., Stephen, Matthew, and Peter. The first three are shown to be brothers, by records of land transfers, and the fourth—Peter—owned and occupied a portion of the three hundred acres of land in Stonington, left by his father, John Randall, and there seems no reasonable doubt of the family relationship as we give it.

In the following pages we have collected and arranged a record of John Randall, Jr., and his descendants—in the male line. It will be seen that his oldest son, Johnathan, and his youngest son, Joseph, are lost in the records. No trace of them has thus far been found.

As a matter of convenience, the records of the other three sons and their descendants are arranged as follows:

PART II.—JOHN RANDALL, 3d., and descendants.

PART III.—NATHAN RANDALL, and descendants.

PART IV.—BENJAMIN RANDALL, and descendants.

In the several wars in which our country has been engaged, our family has been faithfully represented. From Rhode Island and other New England States, a number of our name were among the patriots in the Revolution; and in the war of 1812, New England, New York and Pennsylvania were honorably represented by officers and soldiers, members of our family.

The war of the Rebellion called out a large number who enlisted in the Union ranks, and the fields of Atlanta, Port Hudson and Virginia, will long be remembered by households whose loved ones fell in the conflict, while the horrors of prison life and death at Salisbury and Andersonville hang like pall over the homes made doubly sad and desolate, by the tortures and sufferings of the victims of that terrible scourge of modern warfare.

And, too, among those whose lot had been cast in the seceding States, we find a number enlisted in the ranks of the Confederate army, and thus, brother against brother, arrayed on the battle field to kill and devour each other.

GENEALOGY

Of a Branch of the Randall Family, 1666-1906.

N. B. The earliest traceable and known ancestor of Gurdon Randall was John Randall, the date and place of whose birth are unknown; he died at Westerly, R. I., about 1684-5. (See page 15 of "Genealogy of a Branch of the Randall Family, 1666-1879," by Paul K. Randall.) He was probably born about 1640-5.

At the time of the publication of that Genealogy it was not known that Gurdon Randall was descended from the same ancestor—a fact which I discovered some two years later. The date of that publication was 1879.

In the following tracing of Gurdon Randall's line, and its continuation down to the present time, 1904, while much care has been exercised to secure the utmost accuracy and completeness, it cannot be said that it may not have some defects; but it is hoped that faults have been reduced to the minimum. From John Randall to Joseph and Ehjah Randall, two brothers, I have taken the record from the above named Genealogy. The remainder of it has been compiled from whatever source would yield a ray of light on the subject.
